ALL 4-WHEELER RIDERS UNDER 16 YEARS OF AGE **MUST** WEAR A HELMET WHEN RIDING ON LAKE PROPERTY.

HUNTING WILL BE WITH SHOTGUN AND ARCHERY ONLY.

DEER HUNTING WILL BE ARCHERY ONLY.

DEER HUNTING WILL SWITCH FROM THE WEST SIDE TO THE EAST SIDE OF LAKE FREDERICK EVERY 5 YEARS.

NO FOOD PLOTS WILL BE PERMITTED. ALL PORTABLE STANDS MUST BE REMOVED FROM THE CITY OWNED PROPERTY AT THE END OF THE HUNTING SEASON.

PEOPLE UNDER THE AGE OF 16 YEARS OLD WILL NOT BE REQUIRED TO BUY A CITY PERMIT TO HUNT ON LAKE FREDERICK AND MUST BE ACCOMPANIED BY AN ADULT.
